Cathy Stannard MB, ChB, FRCA, FFPMRCA, Consultant in Complex Pain and Pain Transformation Clinical Lead NHS Gloucester Clinical Commissioning Group UK.

Dr Cathy Stannard was a Consultant in Pain Medicine for 23 years and is now Consultant in Complex Pain/Pain Transformation Programme Clinical Lead for NHS Gloucestershire CCG. She has published widely on aspects of pain management, evidence, and opioid therapy and potential implications of analgesic prescribing for public health. She has chaired working groups for the Medical Royal Colleges, professional organizations and policymakers on Pain and Substance Misuse, Best Practice in Opioid Prescribing, Pain and Addiction and Pain Management in Secure Environments. Cathy is involved in the work of a number of bodies including the WHO, PHE, NHS England, MHRA, European Medicines Agency, NICE and the

Cochrane collaboration. She lectures nationally/internationally on use of opioids and problem opioid use to policymakers, pain professionals and other medical disciplines. She has led a national strategy for improving pain management in prisons. Cathy frequently contributes to conversations opioids and painkiller addiction in the media.

Roger Knaggs BSc, BMedSci, PhD, FFRPS, FRPharmS, FFPMRCA, Associate Professor in Clinical Pharmacy Practice University of Nottingham UK.

For nearly ten years, Roger's main role was to provide a clinical pharmacy service to the Anaesthetics directorate and to contribute to clinical activity in the multidisciplinary Pain Management Service at Nottingham University Hospitals NHS Trust. In September 2011, he was appointed to a new clinical academic position that provides teaching and research opportunities whilst maintaining regular clinical practice. Roger's major research interests relate to understanding the patterns and use of analgesic medicines in everyday clinical practice, applying evidence-based therapeutics and interventions to improve medicines optimisation for analgesic medicines.



Roger is a Fellow of the Royal Pharmaceutical Society and chair of the RPS Accreditation Panel. He represents the RPS on pain management issues in both online and traditional media, including regular comment for BBC Regional Radio. He is a past chair of the United Kingdom Clinical Pharmacy Association Pain Management Group. Roger is currently Honorary Secretary of the British Pain Society.
